Main results of the Council

The Council adopted a **key issues paper** on competitiveness and innovation, as well as conclusions on the **single market review**. Both documents will be submitted to the spring meeting of the European Council, to be held in Brussels on 13 and 14 March.

The Council reached an agreement on the main elements for the launch of a **fuel cells and hydrogen joint technology initiative**.

ITEMS DEBATED

PREPARATION FOR THE SPRING EUROPEAN COUNCIL

Key issues paper on competitiveness and innovation

The Council held an exchange of views on the Lisbon policy package for growth and jobs and adopted the key issues paper (6993/08) with a view to its submission to the 2008 Spring European Council.

Single market review - Council conclusions

The Council exchanged views on the Commission's Communication from November last year on"A single market for the 21st century Europe" ("Single Market Review") in which the Commission sets out its views as to how the functioning of the internal market can be further improved and better respond to globalisation and other challenges. The Council adopted conclusions addressed to the European Council inviting it to endorse the general orientation of a policy for the internal market based on the Single Market Review and the conclusions.

These conclusions are to be found in document 6992/08.

STRATEGIC ENERGY TECHNOLOGY ACTION PLAN

The Council held an exchange of views on the strategic energy technologies action plan (SET-plan).

The exchange of views, based on a questionnaire drawn up by the presidency (6155/1/08), focussed on energy-related research as well as on the impact of the plan on the competitiveness of European industry.

The debate revealed a broad consensus on the importance of the SET-plan in order for the EU to be a leading actor in this area and on the new opportunities that it might represent for European companies. Research in this field could also significantly contribute to the reduction of greenhousegas emissions.

Conclusions on the SET-plan will be adopted at the Transport, Telecommunications and Energy Council meeting on 28 February, with a view to providing input for the Spring European Council.

The conclusions are based on a Commission communication (15458/07) presented last year in response to a request from the 2007 Spring European Council, where it was recognised that there was a need to step up energy research, in particular to boost the competitiveness of sustainable energies, notably renewables, and low carbon technologies and to pursue the further development of energy efficient technologies.

JOINT TECHNOLOGY INITIATIVE ON FUEL CELLS AND HYDROGEN

The Council reached an agreement on a general approach¹ for the setting up of a fuel cells and hydrogen joint technology initiative (JTI) (6115/08).

This JTI is aimed at coordinating European research efforts by providing a framework encouraging large companies and small and medium-sized enterprises (SMEs) throughout the EU to cooperate between themselves together with other stakeholders within the fuel cells and hydrogen field.

Major specific objectives of the initiative include:

- enabling market breakthrough of fuel cell and hydrogen technologies, thereby allowing commercial market forces to drive the substantial public benefits;
- placing Europe at the forefront of fuel cell and hydrogen technologies worldwide;
- reaching the critical mass of research effort to give confidence to industry, public and private investors, decision-makers and other stakeholders to embark on a long-term programme;
- leveraging further industrial, national and regional investment in research and technological development.

This JTI is a research programme that aims, over the next six years, to speed up the development of fuel cells and hydrogen technologies in Europe so that they can be brought onto the market between 2010 and 2020. The EU would contribute EUR 470 million and the private sector is expected to raise a similar amount.

A general approach is an agreement on the essential elements of a legal act, pending the opinion of the European Parliament.

In the light of climate change and the need for significant reductions in cumulative greenhouse gases and pollutants, fuel cells and hydrogen have the potential to become a viable alternative to traditional energy sources. Fuel cell and hydrogen technologies are not commercially available at present and further research and technical development is needed before they can be brought into use.

JTIs were introduced in EU's Seventh Framework Programme for research (2007-13) as a way of creating public-private partnerships in research at European level.

The first four JTIs were adopted in December 2007.

ANY OTHER BUSINESS

The Council took note of information regarding the following items:

(a) CO2 emissions from cars

The presidency and the Commission informed the Council on the state of play on this draft regulation (5089/08), which will be the subject of a policy debate at the next Environment Council meeting on 3 March 2008.

(b) **Defence package**

- (i) Communication on a strategy for a stronger and more competitive European defence industry (16682 /07)
- (ii) Draft directive on simplifying terms and conditions of transfers of defence-related products within the Community (16534/07)
- (iii) Draft directive on the coordination of procedures for the award of certain public works contracts, public supply contracts and public service contracts in the fields of defence and security (16488/07)

The Commission informed the Council about the main content and objectives of the proposed legislative package.

(c) Consumer markets scoreboard

The Council took note of a presentation on the initiative for creating a consumer scoreboard.

The consumer scoreboard will be a new policy tool to evaluate, on the basis of 5 main indicators (prices, consumer complaints, possibility of switching providers, consumer satisfaction and safety), whether consumer markets function properly. It would be integrated into the single market scoreboard.

(d) Internal market scoreboard

The Council took note of the latest data regarding the transposition of internal market directives into national law and their implementation .

(e) Conference on innovation and clusters

The Council took note of the outcome of this conference, held in Stockholm on 22 and 23 January (6440/08).

(f) Research programme on quality of life for older people through the use of new technologies ("Ambient Assisted Living" programme).

The presidency briefed ministers on the state of play.

(g) Draft decision on the participation by the Community in a research programme aimed at supporting SMEs working in the field of research and development of SMEs (Eurostars)

The Council took note of a progress report (5881/08).

(h) Better regulation

The Council took note of the second strategic report on "better regulation" (6840/08).

It will revert to this subject at the next meeting of the Competitiveness Council on 29-30 May 2008.

The report assesses progress in all areas of the better regulation initiative (simplification, impact assessment, reduction of administrative burdens, consultations with stakeholders) and proposes further guidelines for these fields.

(i) Climate-energy legislative package

The Council took stock of information provided by the presidency on this package. The package will be the subject of a policy debate at the Energy Council meeting on 28 February and at the Environment Council meeting on 3 March.

(j) Goods package

The Council took note of the outcome of the European Parliament vote on 21 February 2008 approving the compromise which had been negotiated with the Slovenian Presidency on behalf of the Council whereby a first reading agreement on the three legislative proposals of the goods package was achieved. The new legal framework will clarify and strengthen the application of the principle of mutual recognition and will thereby facilitate access to the internal market not least for small and medium sized enterprises throughout the EU. The new rules will also improve market surveillance and strengthen the confidence of consumers. (6814/08).

OTHER ITEMS APPROVED

RESEARCH

Scientific cooperation agreement with Switzerland (EC and EURATOM)

The Council adopted a decision approving the conclusion of an agreement between the European Community (EC) European Atomic Energy Community (EURATOM) of the one part, and Switzerland of the other part, for research and development cooperation in several fields (5656/08).

The agreement was signed in June 2007 and has been applied provisionally since 1 January 2007.

Scientific cooperation agreements with Egypt and Israel

The Council adopted decisions approving the conclusion of agreements on scientific and technological cooperation with Egypt (5654/08) and with Israel (5655/08).

Committee for the fusion programme - EU enlargement

The Council adjusted the weighted voting system of the consultative committee for the fusion programme following the accession of Bulgaria and Romania on 1 January 2007 (5658/08).

EXTERNAL RELATIONS

EU/Georgia - Partnership and cooperation agreement

The Council adopted a decision on the Community position to be adopted in the cooperation committee established by the partnership and cooperation agreement with Georgia in relation to the establishment of a subcommittee on justice, freedom and security.

Transnistria (Republic of Moldova) - Visa ban

The Council adopted a common position updating the list of persons targeted by a ban on travel to the EU and extending it for 12 months.

The list now contains 19 names (see Official Journal of the EU, L 51, 26.2.2008, p.23).

In 2004, the Council adopted restrictive measures against persons deemed responsible for the design and implementation of the intimidation and closure campaign against Latin-script Moldovan schools in Transnistria.

EU/Central Asia/Caucasus countries - Partnership and cooperation agreements - EU enlargement

The Council adopted decisions approving the signing and provisional application of protocols to the partnership and cooperation agreements with Uzbekistan (8137/07), the Kyrgyz Republic (8873/07) and Tajikistan (8837/07) in order to take account of the accession of Bulgaria and Romania to the EU in January 2007.

Burma/Myanmar - Restrictive measures

The Council adopted a regulation approving the practical implementation of tougher restrictive measures in respect of Burma/Myanmar (6271/08).

The regulation extends and updates the list of enterprises, legal persons, entities or bodies subject to a travel or investment ban.

The regulation provides for a prohibition on investments in Burmese state-owned enterprises and a ban on the provision of financial assistance to them for any supply of goods and technology and on the provision of related technical assistance or training.

This regulation repeals the Regulation (EC) No 817/2006.

The Council adopted conclusions on Burma/Myanmar on 18 February 2008 (see press release 6946/08).

In October, the Council condemned the brutal repression by the Burmese authorities of peaceful protestors and the continuing serious violations of human rights in Burma/Myanmar.

EU/Mexico - Partnership Agreement - EU enlargement

The Council adopted a decision approving the conclusion of a second additional protocol to the economic partnership, political coordination and cooperation agreement with Mexico to take account of the accession of Bulgaria and Romania to the EU.

The agreement was signed in Brussels in December 1997 and entered into force in October 2000.

FISHERIES

New data collection and management system

The Council adopted a regulation establishing a Community framework for the collection, management and use of data in the fisheries sector and support for scientific advice regarding the Common Fisheries Policy (16806/07).

The new rules are aimed at improving the EU's data collection system; they cover the whole process, from the collection of data in ports or at sea to its use by end-users (bodies with a research or management interest in the scientific analysis of data in the fisheries sector). Moreover, the regulation is intended to develop multi-annual national sampling programmes covering, in particular, biological, socio-economic, and ecosystem data.

The multi-annual Community programme for the collection, management and use of biological, technical, environmental and socio economic data will be drawn up for three-year periods and the first period will cover 2009 to 2010 inclusive.

This programme should enter into force before spring 2008.

TRADE POLICY

Antidumpings

- Ferro-silicon from third countries

The Council adopted a regulation imposing a definitive anti-dumping duty and collecting definitively the provisional duty imposed on imports of ferro-silicon originating in China, Egypt, Kazakhstan, the former Yugoslav Republic of Macedonia and Russia (5903/08).

- Antidumping - Bicycles from China

The Council adopted a regulation maintaining Regulation No 71/97 on the extension of the antidumping duty imposed on imports of bicycles originating in China to imports of certain bicycle parts from China (5827/08).
