# Background note<sup>1</sup> AGRICULTURE AND FISHERIES COUNCIL Brussels, 21 January 2008

The Council will be chaired by Mr Iztok JARC, Slovenian Minister for Agriculture, Forestry and Food.

The Council will meet at 11 a.m. on Monday 21 January 2008. The Presidency will present its work programme in the field of Agriculture and Fisheries. Then the Council will try to reach **political** agreement on the simplification of **cross compliance** provisions.

The meeting will continue in the afternoon, with information from the Commission on the fisheries partnership agreement with **Mauritania**. At the end of the session, the Council will hold a **policy debate** on the "Health Check" of the Common Agricultural Policy

### **Presidency Work Programme**

Mr Iztok JARC will briefly give an overview of the work programme of the Slovenian Presidency in the field of Agriculture and Fisheries  $(16786/07)^2$ .

## **Cross compliance**

The Council will try to reach a political agreement on the Commission proposal to simplify the current rules for cross-compliance  $(12585/07)^3$ , which were introduced for the first time during the CAP reform of 2003.

The main improvements proposed in the Presidency compromise package are:

- the abolition of the 10-month rule;
- the possibility of not reducing direct payments for de minimis and minor infringement cases;
- the setting of the *de minimis* threshold at EUR 100 (instead of EUR 50);
- the postponement of the date of identification of parcels for new MS;
- a phasing-in for the new Member States applying the Single Area Payment Scheme (SAPS).

The outstanding issues on which Ministers will provide their position are the phasing-in timetable and the possibility of partial payments.

The European Parliament's opinion was adopted on 11 December 2007.

#### **Health Check**

The Council will hold a *policy debate* on the communication on the "health check" of the CAP since its 2003 reform (15351/07).

The discussion will be framed by the following Presidency's questionnaire which entails the first exchange of views of delegations on that issue<sup>4</sup>, namely the **improvement of the single payment scheme**, the challenging of **environmental** concerns and the way to construct a convincing argument, stressing the vital role that the CAP plays in **societal expectations**.

- 1. Does the Council agree that the Commission's Communication correctly analyses both the principal evolutions since the reforms agreed in 2003/4 and the main challenges to the CAP in the years ahead?
- 2. In general terms, is the level of ambition and the scope of the adjustments broadly outlined in the Communication an adequate response to these challenges?
- 3. Does the Council believe that the Communication identifies avenues for action that would at the same time better align the CAP with general societal expectations while preserving the
